Last Week in Review


- Roughly 20% of US corporates published their earnings; sales and earnings growth show, so far, an improvement over the previous quarter which was already strong. In terms of surprises, we see an improvement in sales surprises and a deterioration in earnings surprise.
- China's central bank let the slide of the CNY continue; the currency fell close to 9% in the past 3 months, to a 1 year low of 6.8143 against the USD. Rather, it lowered further the fixing of the CNY beyond 6.7 in a sign that monetary easing was underway.
- D. Trump called the European Union and China currency and interest rates manipulators; he also questioned the Fed's tightening, saying it hurt the economy by strengthening the USD, and raising the weight of government debt coming due. He finally threatened of new tariffs on 500 bn\$ of Chinese imports. The G10 on Sunday voiced concern that trade tensions posed a risk to global growth.
- In the UK, Vote Leave was fined for breaking electoral laws which could, according to some lawmakers, have influenced the result of the vote. This comes at a time when a growing number of lawmakers are discussing the need for a second referendum to end a political quagmire in Parliament.
