

News highlights

- The first trading day of the year began with a bang, with global stocks rallying and the S&P 500 clocking a new record.
- Equity gains were mainly driven by the People's Bank of China which unveiled fresh stimulus measures, cutting the reserve requirement ratio for commercial lenders across the board by 50bps, releasing roughly \$115bn of fresh liquidity into the financial system.
- Apple shares hit \$300 for the first time, amidst a wider rally in technology stocks. This was also in part due to a deal forged with former HBO chief executive Richard Plepler, to produce video content for a new streaming service, Apple TV+.
- A US airstrike on Iran which killed a high-level military leader later reversed the risk-on sentiment and rising tensions have pushed the price of Brent crude above \$70 per barrel.
- Spain's interim prime minister Sanchéz managed to secure backing from the ERC - Catalonia's largest separatist party.



EUR vs. USD


