

Weekly Market Snapshot

30th November 2020

News highlights

- Equity markets had another great week on continued optimism related to vaccine and fading US political uncertainty.
- The U.S. Dollar Index slid to a two-year low (and €/\$ a two-year high), gold prices fell for a third-straight week, and crude oil prices continued to rally for a fourth week while core sovereign bonds saw little movement last week.
- The narrowly focused Dow Jones Industrial made headlines by reaching an all-time record high, crossing the 30,000 threshold for the first time.
- The announcement of a third vaccine candidate from AstraZeneca helped markets with the perspective of an easier to distribute solution while testing protocols being question marked
- The US General Services Administration acknowledged Joe Biden as the winner of the presidential election, allowing the transition process to proceed more smoothly.
- The nomination of Janet Yellen as the new US Treasury Secretary (to be confirmed by Senate) also supported markets on the perception of her ability to work closely with the Fed as a "powerful policy tool, a battle-tested leader and a trusted voice on the economy"
- The release of preliminary Eurozone business activity, with composite PMI falling to a six-month low of 45.1, added to the likelihood that the euro area will see GDP contract again in Q4. Analysts current half-full glass lenses supported the forward-looking perspective of an even-stronger rebound in Q2/Q3 of 2021.
